Activities of LCHR from January to March, 2016

On January 11, 2016, Ravi Sagar and Shobha K.P. appeared before the National Commission for Minority Educational Institutions, Delhi for hearing of 11 schools among which were 5 from Karnataka, 2 from Tamil Nadu and 1 from Delhi. 10 schools were granted minority status certificate and one was listed for further hearing in August 2016. Further they have filed 2 more schools for the grant of minority status certificate.

On January 16, 2016, Ravi Sagar gave a lecture on "RTE and It's Implications" in a "In-Service Teachers' Training Programme" at St. Paul's Institute of Education, Phesama, Nagaland in which 105 teachers from different schools participated.

On January 18 and 19, 2016, Abinash Narzary participated in a two-day workshop on "Liberating Social Activism through Social Media" organised by WAY Foundation at Chandmari, Guwahati.

On January 21, 2016, Ravi Sagar was the resource person and spoke on "Recent Legal Provisions Related to Management of Institutions" at MSFS Provincial House, Narengi in which community leaders participated.

A group of 3 officers from NITI Ayog, Ministry of Minority Affairs, Govt. of India visited the office of LCHR on January 21, 2016 for monitoring and field verification of the project "Nai Roshni" of 2014 – 2015. The Director of LCHR welcomed the team and briefed them implementation of the project.

On January 22, 2016 the team along with the



Deputy Director of LCHR and Abinash Narzary visited Simelibari and South Mandakata under Bezera Development Block, Kamrup, Assam. The officers spent whole day meeting the trainees and the beneficiaries of the training programme. The team thanked LCHR for implementing the project efficiently. They expressed their gratitude for the warm welcome and the hospitality offered.

After the cozy winter vacation LCHR team was brought together at Umsiang, Meghalaya for a two-day workshop on January 24 and 25, 2016 to rejuvenate before the team enters into the activities of the year ahead. The team spent time with each other relaxed, enjoyed and returned with much life and energy.



On January 30, 2016, Shobha K.P. and Abinash Narzary were the resource persons in 3 legal awareness camps on Motor Vehicle Laws, Assam Excise Act and MGNREGA organised at Teldipot, Datalpara and Fatashil Ambari in the Kamrup district of Assam. The camps were organised in association with District Legal Services Authority, Kamrup. The numbers of participants were 45 at Teldipot, 38 at Fatashil and 50 at Datalpara.

On January 31, 2016, Shobha K.P. and Abinash Narzary facilitated the first workshop for the Legal Fraternity at Jowai. The workshop was held in Cathedral Church. 4 lawyers and Fr. Hilarius participated. Discussion was made on formation of Legal Fraternity and conducting legal awareness programmes in the rural areas. Issues confronting the people were discussed. It was decided that the lawyers would move out to the rural areas for awareness programmes.



From February 1 to 3, 2016, training programme for all the members of Manab Adhikar Manch (human rights groups) of Dibrugarh and Tinsukia districts was organised by LCHR at Kristo Ashaarama, Mancota, Dibrugarh. Members of the groups were trained on the role of Child Welfare Committee (CWC) in providing free & compulsory education to the children, group management skills, ways and means in preventing child labour in order to provide free & compulsory education, implementation of RTE in the schools of plantation areas of Assam etc. The resource persons were Mrs. Sewali Borborah, Chairperson of CWC, Dibrugarh, Felcita D' Souza, Programme Coordinator, LCHR, Mr. Satya Narayan Boruah, District Legal and Probation Officer, District Child Protection Unit,



Tinsukia, Fr. Naos Lakra, social worker and Mr. Santosh Ekka, Advocate.

Shobha K.P. and Abinash Narzary went to Diphu on February 5, 2016 for looking into the possibilities of forming the Legal Fraternity over there. They met Bishop Rt. Rev. Paul Mattekkat and discussed about the formation of Legal Fraternity in Diphu.

From February 5 to 7, 2016, training programme for all the members of the Manab Adhikar Manch (human rights groups) of Udalguri, Nagaon and Sonitpur districts of Assam was oragnised at DBSTI, Tezpur by LCHR. The members were trained on the role of Child Welfare Committee (CWC) in providing free & compulsory education to the children, group management skills, ways and means in preventing child labour in order to provide free & compulsory education, implementation of RTE in the schools of plantation areas of Assam etc. The inaugural programme was attended by Hon'ble Sri Mridul Kumar Kalita, District and Session Judge, Sonitpur, Fr. Cletus Sebastian, Director, DBSTI and Ravi Sagar. The resource persons of the programme were Mr. Kanakeswar Sharma, Chairperson, CWC, Sonitpur, Mr. Soniram Guwala, Assistant Labour Commissioner, Sonitpur, Felcita D' Souza, Program Coordinator, LCHR and Mr. Amal Dutta, Advocate, Gauhati High Court.



On February 7, 2016, the meeting of the district coordinators of 5 districts of Assam was held at DBSTI, Tezpur.

On February 11, 2016, Ravi Sagar & Shobha K.P. visited Alternative Law Forum, Bangalore as an

exposure visit. They had a good interaction with the Chairperson of the organisation Ms. Darshana Mitra and the other staff members.

On the same day, Ravi Sagar delivered a lecture on "Educational and Cultural Rights" at a regional workshop organised by the Karnataka Regional Education Commission (KREC). The workshop was held at CROSS Karnataka. Shobha K.P was also present in that workshop.

On February 12, 2016, Ravi Sagar was the resource person and spoke on the "Right to Education and Its Implication" to the members of the KREC at KROSS, Bangalore represented by the heads of Educational Institutions.

Abinash Narzary attended the second workshop of the Legal Fraternity at Tezpur on February 13, 2016 which was held at Bhairabkunda in Udalguri district. 8 members of the fraternity were present. Discussion on how to carry out more activities in the rural areas was done. It was decided to organise awareness programmes on "Family Law" in 6 places.

LCHR celebrated its 10th foundation day on February 15, 2016 in its office. It celebrated its 9 successful years of dedicated and committed work



for the poor, marganilised and the needy.

On February 16, 2016, an interview was conducted by LCHR in its office for the recruitment of new staff members.



On February 21, 2016, Ravi Sagar, Shobha K.P. and Abinash Narzary facilitated workshop for the legal fraternity at Shillong, Meghalaya.



On February 23, 2016, Ravi Sagar attended a two-day consultation on "Adivasi Issues" organised by PAJRA at Bishop's House, Tezpur. He spoke on the "Constitutional Mandate and Its Values" to the 46 participants.

On February 27, 2016, Ravi Sagar and Abinash Narzary facilitated workshop for the Legal Fraternity at Bishop's House, Imphal, Manipur.

Planning was made to install legal aid boxes and organise legal awareness programmes in Mizoram. Planning was also made to strengthen the legal fraternity and have its office in Aizawl.



On March 4 and 5, 2016, Hemanta Dahal and Mousumi Kalita from LCHR, along with Shobha K.P. attended a workshop on 'Constitutional Connects' organised by Bosco Reach Out at Ulubari. Ms. Binita Singh, the founder of 'We the People' Organization, New Delhi was the resource person. There were participants from 15 voluntary organisations from different places of North East India.

On March 5, 2016, Ravi Sagar gave a lecture on "International Human Rights Law" at Tata Institute of Social Sciences (TISS), Guwahati Campus to the students of those who have chosen Human Rights as their specialization.



Abinash Narzary attended the second workshop of the Legal Fraternity at Agartala on March 6 and 7, 2016 as the facilitator. He interacted with 4 lawyers and Fr. Harry D' Silva and shared the ideas of how to strengthen the legal fraternity in Tripura. Planning was made to organise awareness programmes on land rights of the tribals and other important laws for the people of rural areas.

On March 12, 2016, Ravi Sagar was the resource person at the conference of the Xavier Board for Higher Education and spoke on laws related to Tax and Labour Welfare to the 17 Principals of the Colleges of Northeast.

On March 13, 2016, LCHR in collaboration with District Legal Services Authority (DLSA), Kamrup organised an awareness programme on "Social Security Schemes" at Gobardhan village under Chandrapur Development Block in Kamrup district of Assam. Abinash Narzary, Hemanta

Dahal and Mausumi Kalita from LCHR were the resource persons. The programme was conducted in presence of about 30 persons from the village. Schemes under National Social Assistance Programme, Mahatma Gandhi National Rural Employment Guarantee Act, National Health Mission etc. were enlightened. Other topics dealt were Indira Awaas Yojana, Pension Schemes, National Food Security Act and Integrated Child Development Scheme.
