3 DAY TRAINING FOR EMPANELLED LAWYERS HELD AT AIZAWL

A 3-day training began at 10 a.m. on March 5, 2015 at Aijal Club, Aizawl. 50 selected trainees representing panel lawyers from different districts of Mizoram and a few law students – who will soon join the legal practice – participated in the training. Mr. Joel Joseph Denga, the Member Secretary, Mizoram State Legal Services Authority (MSLSA) welcoming the dignitaries to the inaugural function said "No one should be denied access to justice for economic or any other reason"

Sharing her experience, Ms. Lalhriatpuii, Retainer Lawyer, said "Fewer people come to the court for justice. By sitting at the front office, I was able to assist in giving hope and justice to the poor and vulnerable sections. I also realized that I need to be patient, kind and sensitive towards them".

Delivering the Key note address, Mr. Ravi Sagar, Director, LCHR said that the training aims at building the capacity of the empanelled lawyers to empower the poor and the marginalized. "In order to do this", he added, "Many organizations like Department of Justice, NLSA, MSLSA and LCHR have come together with carefully arranged activities spread over a period of 8 months. The lawyers are called to exhibit maximum concern and sensitivity in discharging this constitutional duty"

Mr. Lalsawta, Hon'ble Minister for Law, Government of Mizoram who was also a senior member of the Bar said, "Justice has become expensive affair for the poor and the weaker. Therefore, empanelled lawyers need the training who are employed to assist the poor to access justice."

Mr. D.K. Mahanta, District and Sessions Judge (Rtd) speaking on the occasion said, "Justice is linked with God and only God can do full justice. God has delegated this divine task to judges, lawyers and court officials." Thus, he reminded the empanelled lawyers to become aware of this divine duty while serving the poor and the vulnerable.

Ms. Shobha K.P., Deputy Director, LCHR, proposed the vote of thanks to the dignitaries who graced the occasion and the participants. While interacting in the introductory session she brought out the need for regular update and to take law practice as a mission with passion.

Mr. Ravi Sagar, the Team Leader, speaking on "Legal aid as a fundamental right" brought home the idea that free aid is not a charity but a right of the vulnerable sections which is embedded in the Constitution of India backed by judicial pronouncement and legislative enactment inspired by the international documents. Mr. Joel Joseph Denga highlighted the function, strength and challenge of MSLSA.

Ms. Zoparliani Khiangte, Asst. Professor, Govt Mizoram Law College defining the term Scheduled Tribe highlighted the rights and legislative protections enshrined in the Constitution of India and various other enactments. Mr. Ravi Sagar complemented by adding various legislative provision towards SC, OBC, working class, rural and urban poor, victims of natural and ethnic conflicts.

Mr. D.K. Mahanta, the Master Trainer highlighted special provisions for civil procedure and criminal procedure with relevant laws with special reference to vulnerable sections and weaker sections. He disclosed various provisions of Criminal Procedure Code and Civil Procedure Code.

Mr. Ravi Sagar facilitated an interesting group discussion and the participants discovered innumerable rights and legislative protections for women, Children, the aged and the people with disabilities.

Ms. Rebecca Lalrindik, Professor Govt Mizoram Law College distinguishing professional ethics from morality she not only clarified the duty of an advocate towards the court, the client, the opponent and the colloquies but also urged the participants to live up to the ideals of the legal profession.

The face-to-face interaction sharing between the Para-Legal Volunteers (PLV) and the empanelled lawyers brought the two together join their hands to strengthen the vulnerable sections to access justice.

The training came to an end at 5.00 p.m. on March 7, 2015. Mr. Joel Joseph Denga welcomed the dignitaries and Ms. Shobha K.P. summed up the 3 day training and she also at the end of the closing ceremony proposed the vote of thanks. Ms. C. Ramdinmawii said that she not only benefitted from the training but also realized the need for legal aid, as constitutional and international obligation. Ms. Zothansangi Hmar said that she is one among the fortunate few chosen for this training.

Speaking at the concluding function Hon'ble Mr. Justice Ujjal Bhuyan, Judge Gauhati High Court and Executive Chairperson MSLSA congratulated the organizers of the

training. He highlighted various aspects of human rights and called upon the trainees not only to deal with human rights but also to respect human rights.

Mr. Ravi Sagar, called upon the trainees as social engineers to apply the skills of training to build up a strong, just and equitable society for all to access justice.
