

am extremely happy to be associated with LCHR for the last nine years. During this period the LCHR has been striving to carry out its vision and mission to reach out to the weakest sections of our society. It has been a marvellous experience to grow along with the people who are in need of our care and compassion. The LCHR with its legal expertise in litigation and in providing legal literacy has brought justice, peace and consolation to many needy people.

While bringing succour to individuals, families and even communities, we at the LCHR realise that there are many other issues that are global in nature. One such concern is climate change which is seriously affecting us. For example, the present drought in India is affecting more than 300 million people in India, a quarter of the population of the country. In Assam itself recent unseasonal rains and floods have brought misery to about one lakh people. Scientists may explain such natural disasters in various ways. But we know that the root cause is human

misbehaviour towards nature and environment. Though we know that all living organisms, the flora and fauna, are interdependent among themselves and with their environment and exist in a harmonious manner, we human beings have destroyed this harmony through our reckless selfish behaviour. Basically we fail to understand that the Creator has provided for satisfying everyone's need, not anybody's greed. This demands that we have to treat our environment gently and all our fellow creatures humanely.

Here we have a model in St Francis of Assisi. We read in his writings how he would burst into song while lovingly gazing at "brother sun", "sister moon." He used the language of fraternity in addressing birds and animals as sisters and brothers. He was always conscious that he was a member of the family of all living beings sharing with them a common abode and environment. This awareness made St Francis to sing songs of praise to the Creator. St Francis wanted others to experience the same closeness with other animals, birds, flowers and plants.

Motivated by this attitude we can work for a future with "climate justice". Orientation on Cluster Formation

LCHR INTERVENTIONS IN 2015-2016

Legal Literacy Camps

LCHR in partnership with District Legal Services Authority (DLSA), Kamrup organized 5 legal literacy sessions on Motor Vehicle Laws, Assam Excise Act, Social Security Schemes and MGNREGA at Fatasil Ambari, Datalpara, Teldipot, Niz Gobardhan and at Hograpara in which over 250 persons participated.



An Awareness Camp on the Rights and Duties of Prisoners was organized by LCHR on March 12, 2016, in association with DLSA, Kamrup at Central Jail, Guwahati. Around 150 jail inmates attended the awareness camp in the presence of the Superintendent of Jail, the Jailor and the Assistant Jailor. The awareness camp was aimed at bringing awareness among them about their rights and duties.



Conciliation & Legal Assistance

LCHR through negotiation and conciliation successfully helped many individuals and families to settle their disputes amicably. A couple in their late fifties was caught up with court procedures for many years. As the days passed, they realized the futility of their litigation and they were willing to settle their dispute amicably. When their engaged lawyers would not hear their plea they came to LCHR for assistance. LCHR encouraged them to place a mutual petition before the

Principal Judge, Family Court, expressing their desire to settle their matter mutually. The Principal Judge not only passed the order of withdrawal of the case for mutual settlement but also appreciated them for the example they set before others.

Litigation

LCHR is also dealing with some cases relating to human trafficking in Gauhati High Court. Ravi Sagar has been the engaged counsel in one of the PILs filed by Bachpan Bachao Andolan (BBA) before the Gauhati High Court. The prayer before the High Court is to direct the Government of Assam to implement the provisions of laws related to children, to register the cases of missing children, formulate guidelines for registration of all persons leaving for employment from Assam and to ensure proper functioning of child protection institutions.

LCHR Associates have also assisted litigants redress their grievances. Several women have been helped to claim their matrimonial rights. Poor people have been helped in litigation especially in land related matters. LCHR assisted 11 schools, among which 5 were from Karnataka, 2 from Tamil Nadu and 1 from Delhi, in obtaining Minority Status Certificate. 10 schools were granted the certificate and one was listed for further hearing in the month of August, 2016.

Training of PLPs



The second training on "Para-Legal & Advocacy Skills" for the PLPs of Chandrapur Development Block, Kamrup District was held from July 18 to 22, 2015 at JAGRITI, Guwahati in which 7 trainees participated. The training was inaugurated by Mr. Pranab Sharma, Advocate, Gauhati High Court. After their first training the PLPs made remarkable contribution for the promotion of social justice in their villages. They were urged to complete the training which would help them to improve their capacity further.

During this training the trainers focused on laws related to Land, PDS, Targeted Public Distribution System (TPDS), laws related to women, provisions related to Free Legal Aid and right to education. Mr. Pranab Sharma, Advocate, Gauhati High Court, Mr. M.K. Borah, Additional Director, Food, Civil Supplies & Consumer Affairs, Mr. Bhaskar Jyoti Kalita, Mr. Satya Narayan Boruah, Mr. Abinash Narzary and Ms. Preeti Rekha Gogoi from LCHR were the resource persons at the training.

Monitoring and Evaluation



On January 21, 2016 a group of 3 officers from NITI Ayog, Ministry of Minority Affairs, Gol, visited LCHR for the monitoring and field verification of the project called "Nai Roshni 2014 -2015" in which LCHR has trained a group of 125 women belonging to minority groups. They were briefed on the implementation of the project. On January 22, 2016 they visited Simelibari and South Mandakata villages under Bezera Development Block, Kamrup district, Assam and met the beneficiaries of the training. The team was satisfied on the implementation of the project efficiently.



Every month LCHR team visited the PLPs, who are undergoing training, for monitoring and evaluation, and to accompany them in their field work. The PLPs shared their field activities, their experiences and the problems faced during the course of action. They shared that they were able to help many people to apply for IAY houses, job cards and get the benefits

of various social security schemes of both the Central and the State Governments. All the PLPs were able to do some useful activities in their own areas. They also organized awareness sessions in which the people from the villages were gathered.

LCHR Team also conducted monitoring and evaluation meetings every month for the evaluation and planning of the activities of the cluster groups and their members in order to make them to work hard to access justice for the people.



The District Coordinators come to LCHR office every month for evaluation and planning of their activities. They are guided and supervised by LCHR Team while they in turn guide the PLPs as well as cluster groups.

Follow-up Training



A 2-day residential follow-up training for the PLPs of Boko Development Block under Kamrup district was conducted at North East Diocesan Social Forum (NEDSF), Kharghuli, Guwahati from 30th September to 1st October, 2015.

At the inaugural function Hon'ble Mrs. Justice (Rtd.) Anima Hazarika, President of the Assam State Consumer Disputes Redressal Commission appreciated the activities of the participants, their motivation and commitment to help the people in the villages. Justice Anima Hazarika outlined the laws related to women, children, RTI, RTE, F.I.R, fundamental duties and constitutional rights. She said that "law is the most powerful weapon to combat corruption and injustice". Dr. M.K. Shrivastav, Assistant Professor of National Institute of Rural Development & Panchayati Raj (NIRD&PR), Guwahati spoke on Panchayati Raj Institutions (PRI) and local Governance system in Autonomous Council Areas of North East India.

Training for PLPs on Advocacy Skills



For the last 3 years LCHR has been Resource Team in "Capacity Building of Tribal Leaders through Para-legal and Advocacy Skill Training" in collaboration with Network of North-East Tribe (NNET). Over a period of 3 years, LCHR trained 88 PLPs from 5 partner organizations of NNET based in Tinsukia, Jagun, Chapar, Baganpara and Kumarikata. Through the trainings and field work they perfected the art of para-legal skills and advocacy. A 6-day review training for the trained PLPs was conducted at National Institute of Rural Development & Panchayati Raj (NIRD & PR), Khanapara, Guwahati from 30th August to 4th September, 2015 in which 36 participants attended.



The training was inaugurated by Hon'ble Mr. Justice (Rtd.) B.D. Agarwal, Judge (Rtd.) Gauhati High Court. Dr. R. M. Pant, Director, NIRD & PR, Khanapara, Fr. Jose Karipadam, Project Coordinator, NNET and Ravi Sagar, Director of LCHR were present at the inaugural. Hon'ble Mr. Justice (Rtd.) P.K. Musahary, Chairperson, State Police Accountability Commission, Assam was present at the concluding ceremony.

The training module included sessions on RTE, National Social Security Schemes (NSSS), Panchayati Raj Institution (PRI), Public Distribution System & National Food Security Act (PDS & NFSA), Consumer Protection Act (CPA), Public Interest Litigation (PIL), Criminal Justice System (CJS), First Information Report (FIR) and Right to Information Act (RTI).

Exposure and Internship



LCHR offers internship to the students of law and social work. They dwell on practical experience. Students from Guwahati as well as from outside take advantage of the internship programme. On July 24, 2015 a group of 9 law students from Jorhat Law College visited LCHR as a part of their exposure programme, to know about LCHR and its activities. On August 18, 2015 a group of 15 students pursuing their master degree in child rights from Assam Don Bosco University visited LCHR as a part of their observation programme. On September 29, 2015, 12 Students from Nagaland, Arunachal Pradesh and Assam visited LCHR. On October 29, 2015 a group of 9 students from Mind India, Guwahati visited LCHR, as part of their exposure programme to know about LCHR and its activities.

Home affairs

The LCHR team had a 2-day workshop on January 24 and 25, 2015 to energize the spirit before entering into the activities of the forthcoming year ahead of them. The team spent lot of time with each other, relaxed, enjoyed and returned with much life and energy. LCHR celebrated its 10th foundation day on February 15, 2016. Fr. Arul Susaimanickam, the Chairman of LCHR visited LCHR office on March 14, 2016.



On February 16, 2016 LCHR conducted interviews for the post of Programme Managers and selected Mr. Hemanta Dahal, Ms. Margaret Thomas Deka, Ms. Pampi Bharadwaj and Ms. Mousumi Kalita. Mr. Ananta Daimari was selected as office assistant. LCHR bid farewell to Felcita D' Souza and Mamoni Dey Sarkar who served LCHR for over 5 years.



PLP Cluster Groups to access Justice

After training PLPs in para-legal and advocacy skills, LCHR realized the need of bringing together the trained PLPs to work for the issues confronting them. Hence, on November 1, 2015, LCHR launched a new programme namely, "Formation of Cluster-Groups among the PLPs and Training them to Access Justice in the Tea Plantations of Assam". It is aimed at bringing the scattered PLPs together into cluster groups in order to work for the protection and promotion of human rights. 18 cluster groups have been formed and are

trained on group management skills. They have chosen to work on rights of children especially on the right to education in the tea plantations. A series of activities have been planned systematically to achieve the objectives of the programme.

Orientation on Cluster Formation

LCHR has made 25 visits to the tea gardens in Dibrugarh, Tinsukia, Udalguri, Sonitpur and Nagaon districts, to interact with the trained PLPs who are actively involved. A team comprising of Ravi Sagar, Felcita D'Souza, Satya Narayan Boruah and Abinash Narzary has visited the tea gardens in 5 districts of Assam motivating the trained PLPs to form them into purposeful cluster groups to access justice.



The purpose of those meetings was to discuss with the trained PLPs not only the formation of cluster groups and its modalities but also prevailing issues among the tea garden labourers. After a series of discussions in five districts it was unanimously decided to work on the issue of right to education among the tea plantation labourers. The cluster groups will make the tea plantation labourers aware of the Right of Children to Free and Compulsory Education Act, 2009 and other laws related to Children.

Training of the Office Bearers

A 3-day residential training on group management skills was conducted for the Office Bearers (OB) of 18 cluster groups of the PLPs at NEDSF, Kharghuli, Guwahati from December 5 to 7, 2015. 42 OBs from 18 groups and 5 district coordinators from Tinsukia, Dibrugarh, Sonitpur, Udalguri and Nagaon districts of Assam attended the training.



Valerian Castelino was the Resource Person at the training. He dealt with the formation of groups and its modalities. He explained to them about the rules and regulations for better functioning. While clarifying the rules of book-keeping and maintaining the group accounts, he introduced to them different kinds of account books to be managed. Generation and management of funds including modalities of loan were also dealt in the training.

Training on Child Rights

Two trainings for the cluster group members were held on the educational rights of children. Chairpersons of Child Welfare Committee, Labour Commissioner, District Legal Cum Probation Officers and other members of child protection institutions participated as resource persons to enlighten the participants on the right of education and prevention of child labour.



The first training was held at Christashram, Mancotta, Dibrugarh from February 1 to 3, 2016. Mrs. Sewali Borborah, Chairperson of Child Welfare Committee (CWC), Dibrugarh was invited to enlighten the participants regarding the role of CWC in providing free and compulsory education to the children.

The second training was conducted from February 5 to 7, 2016 at DBSTI, Tezpur to train the members of cluster groups on how to work with Child Welfare Committees and the tea garden management in implementing the provisions of RTE among the children of the tea garden labourers. Mr. Mridul Kumar Kalita, District and Session Judge, Sonitpur highlighted on Child Rights, Child Labour, Free and Compulsory Education under RTE and Prevention of Children from Sexual Offences under POCSO.



Formation of 15 Legal Cells:

A Dream into Realty...

In response to the mandate, LCHR has taken initiative to form 15 legal cells in different parts of the North East India in order to access justice. Efforts have been made to gather human rights lawyers to form purposeful legal cells in those areas in order to tap the resources of legal competence among them in

the region. LCHR team outlined the need for coming together under a common platform in order to chalk out activities which will benefit the poor and the needy. This coming together has resulted in increased professional expertise, advocacy skills and widening network among the like-minded lawyers and organizations. This will also motivate them to take up the cause of the poor and the needy in their

own locality. LCHR team constantly assisted these legal cells to organize workshops and to encourage them in all their endeavours.

1. Agartala Legal Cell

The Agartala Legal Fraternity being enthusiastic of the idea of coming together, formed the legal cell group among themselves. During the first workshop held at JUST, Agartala, the members expressed that it would enable them to serve the poor and the needy in legal matters at a reasonable cost. They also found mutual support in the profession.

2. Aizawl Legal Cell

The first workshop of the Legal Fraternity of Aizawl brought a handful of lawyers but committed with a deep interest in forming themselves into a Legal Cell. Their coming together resulted in forming a legal cell to take up common issues and help the deprived sections of the society in legal matters.

3. Bongaigaon Legal Cell

In Bongaigaon, the first workshop was held at Chapaguri with the view to form a legal cell. The members of the legal fraternity are making all efforts to gather not only practising advocates but also students of law, judges and magistrates. They expressed their happiness in forming the legal fraternity which will enable them strengthen their professional ties.

4. Dibrugarh Legal Cell

The Dibrugarh Legal Fraternity eagerly welcomed the idea of forming a legal cell and suggested that the Legal Cell can effectively function apart from the conventional work of practising in the court by organizing legal awareness camps for the ignorant masses of the society.

5. Diphu Legal Cell

In February, 2016 LCHR visited Diphu to look into the possibilities of creating the legal cell over there. It was found that the time has not yet ripened as there are a few interested members. The handful of them felt that it would give them an edge in networking among the legal fraternity from the other States of North east India.

6. Guwahati Legal Cell

In Guwahati, the law graduates and advocates have given a very positive response towards the formation of legal Cell. They have expressed their willingness and have come forward to make this endeavour a success. There is a big number of law students who are very keen to take advantage of this networking.

7. Imphal Legal Cell

The first workshop held at Mantripukhri, Imphal convinced the Imphal Legal Fraternity the need for coming together on a common platform and take up activities and privileges that can be undertaken and enjoyed by the legal fraternity. They are impressed that legal fraternity network in the northeast would widen their horizons.

8. Itanagar Legal Cell

Itanagar has vibrant, young and interested lawyers who welcomed the idea of LCHR. They said that it is their sacred duty to voice the voiceless and educate the ignorant in the field of law. They regretted for not reaching out to the villages where their own people are struggling with law related matters.

9. Jowai Legal Cell

LCHR facilitated the first workshop in Jowai in November, 2015. Appreciating the efforts of LCHR and the innovative idea of bringing the lawyers together to work for the benefit of the society in legal matters, the participants expressed their desire to do all that is necessary to implement this idea.

10. Kohima Legal Cell

After consultation and discussions, LCHR visited Kohima legal fraternity in February and March, 2016. To their advantage, the experienced lawyers in the group exhorted its members to work diligently and they are now growing from strength to strength. Participation of law students in the legal cell added a new dimension.

11. Miao Legal Cell

Legal profession in Miao, Arunachal Pradesh is in the bud. Students of Law often move to other parts of the North Eastern States and particularly to Guwahati for their graduation in law. Though formation of legal fraternity in Miao is at the infancy stage yet there lies huge potential towards the growth of the fraternity.

12. Nongstoin Legal Cell

In Nongstoin it has been found that the ratio of students pursuing law degree is higher compared to practicing members of the Bar and the Bench. Formation of legal cell in Nongstoin has better

prospects in the years to come. Therefore, plans are afoot to make the fraternity more vibrant and functional.

13. Shillong Legal Cell

The big number in the members from the Bar and the Bench including the students of law are optimistic as to the formation of the legal fraternity in Shillong. They believe in advocates becoming the voice of the voiceless. The Shillong Legal Fraternity has conducted several legal awareness programmes and addressed various legal issues of the society.

14. Tezpur Legal Cell

The Tezpur Legal Fraternity accepted the idea of

formation of the legal Cell. They believe that they would get a platform to come together, share their legal expertise and help one another. They have ventured to conduct legal awareness programme in the rural villages on relevant topics to solve legal issues among the poor and the marginalized.

15. Tura Legal Cell

The Tura Legal Fraternity comprises of several members from the Bar and the Bench who are eager to form the network of legal fraternity and address the legal issues of their area. Plans are afoot to include more and more number of members to the fraternity. Their enthusiasm will unfold the dream.

My experience your inspiration

am Bipul Sangma, PLP from Niz Gobardhan village, Chandrapur, Kamrup, Assam. I completed my training from LCHR in 2015. In this training, I came to know about the various schemes and projects available for the development of the rural people. In the training, emphasis was given to enable the participants to know the rules and procedures to get correct information from the government offices through RTI. I also learnt how to make RTI applications. To my pleasant surprise, I got reply to my first RTI application in which I had enquired about the "Indira Awaas Yojana" a housing programme for the rural people. I got a list of people who were awarded the housing facility.



When enquired about it in the village, I found that the listed people have not got the houses. After informing the people concerned and the villagers, I wrote an application to the Block Development Office requesting it to provide housing facility to the listed people. I could not believe myself when these persons whose names appeared in the list were later called to the Block Office and were informed that their houses will be constructed soon. Martha Marak, Sunita Marak, Mukta Sangma, Sushma Barman and Sudon Das from Niz Gobardhan village in Kamrup got houses under "Indira Awaas Yojana" in 2015 with my intervention.

- collaboration with NNET in which 36 participants from Tinsukia, Jagun, Chapar, Baganpara and Kumarikata attended.
- 2-day residential follow-up training for the trained PLPs from Boko in Kamrup district was conducted at NEDSF, Kharghuli, Guwahati from September 30 to October 1, 2015.
- 3-day residential training on group management skills was conducted for the office bearers of the cluster groups at NEDSF, Kharghuli, Guwahati from December 5 to 7, 2015 in which 42 Office

Bearers from 18 cluster groups and 5 District Coordinators attended.

Their experience our inspiration

am Megha Marak, a trained PLP from Chandrapur Development Block in Kamrup district of Assam. I received first training on paralegal and advocacy skills from LCHR in February, 2015. I have filed many applications under the provisions of RTI Act to obtain information about the development projects taking place in our area.

I filed an application on September 22, 2015 to the Chandrapur Development Block seeking information about the total amount of funds released and the schemes undertaken at No. 3 Pachim Mayong Gram Panchayat during the financial years from 2012 to 2015.



I received the information on November 3, 2015 from the Public Information Officer (PIO) who stated that during the financial year 2013-2014 an amount of Rs. 1,20,000/- was sanctioned to the Gram Panchayat for the construction of a road from Ghoramarajanpar to Ganesh Mandir playground and Rs. 2,80,000/- for the construction of fishery at Ghoramara near Kaminidal in the financial year 2014-2015. The PIO also stated 100% physical progress and the entire amount was utilized for the construction of the road and fishery.

I am sure that the construction of the road has never taken place in that financial year. Further, the fishery was not constructed at the described place but a small pond was constructed in a private land which is about a kilometer away from described spot. Hence, after getting these information, I with the help of village people organized 2 meetings at Ganesh Mandir to discuss about the matter. The villagers, in writing, requested me to enquire more about it and requested me to approach the Government authority for the strict action against the Gram Panchayat.

Accordingly, I submitted a letter written by the villagers to the Deputy Commissioner (DC) of Kamrup (Metro) district demanding to carry out fully the work of construction of the same road and the fishery and also to initiate action against those who are involved in this corruption. My letter was accepted by the office of DC and registered as case no. 7888/16 on March 9, 2016. The district officials ordered for verification report at the earliest.

am **Shiblal Panika** a LCHR trained PLP, presently serving as Udalguri district coordinator. I help my villagers to write RTI applications to know the status of development projects and activities in my village. I have assisted people to open bank accounts. I wrote applications to the tea garden management to provide fire-wood to the labourers which was not provided for the last one year. I met

(DLSA), Udalguri to discuss with him to register the PLPs as Para Legal Volunteer under DLSA, Udalguri. I collected the required forms to apply for myself and other LCHR trained PLPs.

I organised a programme on May Day in which 300 people participated. Member Secretary of DLSA, Udalguri was the resource person. I work hard to settle land disputes among the villagers

without taking them to the court. Recently I helped a family to claim their provident fund arrears. I have helped 83 families to fill up NRC forms. I learnt about the availability of various welfare schemes to help my people. In the last two months I have helped 10 people to get birth certificates, and through court order to another 6 people.

I conducted several awareness meetings on RTE, NRC, Human trafficking, Plantation Labourers Act and witch-hunting and settled a few disputes relating to them. I discuss the problems related to the education of children in the plantations. I make several visits to various tea gardens to instruct scattered PLPs about the advantages of the formation of cluster groups. I tell my people about the need of raising their voice against any form of injustice, especially child labour.

Experience of Interns

am Aloli Assumi, pursuing Masters in Social Work at NERIM group of Institutions, Guwahati. Hearing from the other friends, I was waiting to grab an opportunity to be part of LCHR as an intern. I love to share my 20 days of fruitful experience in LCHR. LCHR has taken keen interest in guiding me and to learn the new concept of Para Legal Persons and their activities which I was unaware of.

I had a wonderful learning experience during my maiden visit to tea garden (Seconne Tea Garden). Interacting with the tea garden workers, understanding their problems and the issues confronting them taught me the practical aspects of all that I am learning in the class room. I learned so much while being an intern in LCHR which I carry with me for the rest of my life as a priceless jewel.

I am Writumoni Sarma, a student at North Eastern Regional Institute of Management (NERIM) persuing Masters in Social Work in the 2nd semester. I have joined LCHR as an intern for a period of one month from 20th April to 20th May, 2016.

LCHR provided me a great platform to experience something new and innovative. I got a taste for peoples' movement for social transformation. I learnt to sense the feelings of the poor, their struggles and the initiative they take to preserve their rights.

LCHR has given me an opportunity to engage in the protection and promotion of Human Rights. During the period of my internship, I visited a tea Garden in Nagaon district with the help of a PLP to know about the medical facilities available for the tea plantation labourers. I attended a meeting of PLPs. I was glad to meet those grass-root bare-foot lawyers who fight for human rights to uphold their human dignity. Even though I was an intern in LCHR just for a month, yet I consider it as a backbone experience of student life. This experience provided deep roots for shoots to sprout in the garden of my professional career of social work.

I am **Kangkana Medhi**, a student of MSW at NERIM group of institutions. I am privileged to do my internship in LCHR. I am grateful to LCHR for guiding me and giving me a chance to learn professional skills. I got an opportunity to be a part of useful discussions on various issues.

Attending a legal awareness programme with PLPs in a tea garden taught me both theoretical and practical lessons. It is a milestone in my career. I will strive to use the knowledge and skills I gained to achieve my career objective. Hope to continue to cooperate with LCHR in the future.


