Achievements in the year 2012-2013

a. Legal capacity building programme among the rural people of Assam in Northeast India :

On January 1, 2008, LCHR launched the programme, "Legal capacity building among the rural people of Assam in Northeast India". Kamrup, Barpeta, Nalbari, Bongaigaon, Goalpara, Udalguri, Morigaon, Nagaon, Sonitpur and Karbi Anglong districts of Assam were chosen for this programme.

In the year 2012-13, LCHR has succeeded in reaching over 5,026 people

including 2,237 women of 85 remote villages of those ten selected districts. The topics highlighted/discussed during the programme were : Right of Children to Free and Compulsory Education Act 2009, Right to Information Act 2005, Mahatma Gandhi National Rural Employment Gurantee Act 2005, Public





Distribution System, Free Legal Aid to the Poor, Rights of the woman and child etc.

In the last 6 years LCHR has conducted 513 legal awareness sessions in which 28, 175 (Male: 15, 376 & Female: 12, 799) people directly participated in the legal literacy sessions in 10 districts of Assam mentioned above.

b. Training on Para-legal & Advocacy Skills:

Since 2008, LCHR has been training people on Para-legal & Advocacy Skills. "Training on Para-legal & Advocacy Skills" is a unique programme of LCHR. The trained persons can be called "bare-foot lawyers". They are trained in order to take the laws straight to the homes of the people.

In the year 2012-13, 167 people were trained in Dhubri, Udalguri, Kamrup, Morigaon, Nagaon, Sonitpur, North Lakhimpur, Tinsukia and Dibrugarh districts





of Assam and North Tripura, Dhalai, Khowai and West Tripura districts of Tripura. In association with the trainees, LCHR organized 305 legal literacy sessions in the respective Panchayats of the trainees.

283 Para-legal Persons from Assam and Tripura are trained by LCHR in a short span of 6 years.



c. Public Hearing on Right to Education :



A "Public Hearing on Right to Education" was held on April 21, 2012 at the auditorium of Deshbandhu Bidyapith Higher Secondary School, Hojai in Nagaon district of Assam. LCHR facilitated the Public Hearing which was organized by Assam State Commission for Protection of Child Rights (ASCPCR).

The Hon'ble Chairperson of ASCPCR, Dr. (Capt.) Suchitra Kakoty, members of

ASCPCR Mr. Pranjal Saikia, Mrs. Runumi Gogoi and Mrs. Kalyani Das, and Adv. Ravi Sagar, Director, LCHR, Mr. Biswajit Pegu, Sub-Divisional Officer (Civil), Hojai, Mr. K. K. Baruah, District Mission Coordinator cum District Elementary

Education Officer, Nagaon district and Mr. Bidyut Bikash Bhagawati, Circle Officer were the guests of honour.

There were a gathering of 900 people from Hojai Sub-Division of Nagaon district in the Public Hearing. Out of 30 (thirty) written complaints the commission had taken up 10 (ten) complaints in the presence of complainants and respondents.



d. Health Check up Camp :

On August 4, 2012, LCHR facilitated Guwahati Refinery to organize a health check up camp for flood affected people of Mayong Development Block in



Morigaon district of Assam. It was held at Pabhakati Kacharigaon Lower Primary School, Sildubi village. There are 398 families in the village.



A team of 10 doctors and 25 para-medical persons deputed by Guwahati Refinery including Dr. A. K. Sharma, Chief Medical Officer, Guwahati Refinery Hospital, Mr. Malay Baruah, Mr. M. Das, Public Relation Officer, Guwahati Refinery, and Dr. P. Choudhury were present in the camp.

Over 700 flood affected people were benefited in the health check up camp.

e. International Human Rights Day Celebration :

In collaboration with Morigaon District Legal Services Authority, LCHR celebrated the 64th International Human Rights Day on December 10, 2012 at the Auditorium of the Morigaon Zila Parishad. About 150 people participated in the programme from different parts of Morigaon district including Judicial Officers, Advocates, Law students, children





different schools and senior citizens of Morigaon district.

More than 50 participants from Kamrup, Nagaon, Udalguri, Morigaon, Sonitpur, Dibrugarh and Tinsukia districts of Assam took part in the seminar. There were trained Para-legal persons of LCHR and representatives from civil society organizations.

g. Minority Status Certificate :

Schools opened to impart education primarily to minority communities could apply for the Minority Status Certificate to the competent authority of the State government and also to the National Commission for Minority Educational Institutions. Many institutions approached LCHR to apply for the Minority Status Certificate on behalf of their institutions.

In 2012-13, National Commission for Minority Educational Institutions issued 77 Minority Status Certificates to the institutions of Northeast India because of LCHR initiative. 13 schools are in pending.

h. Conciliation and Legal Assistance :

Since its inception, LCHR facilitated free conciliation and legal assistance to the poor and weaker sections of the society. In the year 2012-13, over 50 poor people were provided free legal assistance.

Training organized by LCHR :

1. A five days training on "Para-legal and Advocacy Skills" was held at Shilpgram, Guwahati, in Kamrup district of Assam from May 31 to June 4,





2012. There were 17 trainees from Moirabari and Kapili Development Blocks of Morigaon district and Bezera Development Block of Kamrup district.

2. A five days training programme on "Capacity building of tribal leaders through Para-legal and skills trainings" was organized from June 6 to 10, 2012



in Shilpgram, Guwahati. The trainees were from Jagun, Tinsukia, Mazbat, Sonitpur and Chapar of Assam. There were 25 participants in the said training programme.

From June 10 to 14, 2012, "Capacity building of tribal leaders through 3. Para-legal and skills trainings" was held at the Auditorium of Association for Social and Human Advancement (ASHA), Damdamia, Tripura. There were 25 participants in the training programme from Mohar Para, Kathalcherra, Kamaranga, Gandhacherra and Damdamia of Tripura.

1st training programme of YEAR I, "Training 180 Para-legal persons among 4. the Tea Plantation Labourers in Assam" was organized from June 22 to 26, 2012 at Shilpgram, Guwahati. The number of participants was 65 from Tinsukia, Dibrugarh, Sonitpur, Nagaon and Udalguri districts of Assam.

From August 21 to 25, 2012, a five days 5. training programme on "Community Managed Sustainable Livelihood



Promotion: Programme for Improved Livelihoods through Empowerment of the Civil Society in Rural North East India" was held at Dholaibil Training Centre, Sonitpur district of Assam in association with Tezpur Social Service Society (TSSS). There were 20 Para-legal persons in the programme.

A five days training programme on "Capacity building of tribal leaders 6. through Para-legal and skills trainings" was held at ASHA, Damdamia, Tripura from September 9 to 13, 2012. There were 25 participants in the training programme from different districts of Tripura.

7. From September 15 to 19, 2012, a five days training on "Capacity building of tribal leaders through Para-legal and skills trainings" was held at Capuchin House, Guwahati. There were 18 participants in the training programme from Tinsukia, Sonitpur, Dhubri and Udalguri districts of Assam.

- 2nd training programme of YEAR I, "Training 180 Para-legal persons among the Tea Plantation Labourers in Assam" was organized from September 19 to 23, 2012 at Shilpgram, Guwahati. There were 52 participants from different tea gardens of Assam in the training programme.
- 9. Training on "Para-legal and Advocacy Skills" was held at Shilpgram,
- Guwahati, from October 30 to November 3, 2012 for the trainees of Morigaon and Kamrup districts of Assam. The number of participants was 15.
- A two days training programme on "Community Managed Sustainable Livelihood Promotion: Programme for Improved Livelihoods through Empowerment of the Civil Society in

Rural North East India" was organized at TSSS training centre, Dhalaibil in Sonitpur district from November 8 to 10, 2012. A total of 32 trainees participated in the training programme.

- 11. From November 16 to 20, 2012, a training programme on "Community Managed Sustainable Livelihood Promotion: Programme for Improved Livelihoods through Empowerment of the Civil Society in Rural North East India" was held at TSSS Training Centre, Dhalaibil under Sonitpur district of Assam. - 13. "Capacity building of tribal leaders through Para-legal and skills trainings" was held at Capuchin House, Guwahati from December 16 to 20, 2013. A total of 20 participants were present in the training programme.
- 14. A five days training programme on "Capacity building of tribal leaders through Para-legal and skills trainings" was held at ASHA, Damdamia, Tripura from January 24 to 28, 2013. The number of participants was 20.



15. A training programme on "Community Managed Sustainable Livelihood Promotion: Programme for Improved

> Livelihoods through Empowerment of the Civil Society in Rural North East India" was organized at TSSS Training Centre, Dhalaibil in Sonitpur district of Assam from February 7 to 11, 2013. There were 11 participants in the training programme.

16. "Training Para-legal personnel in Kamrup district of Assam in Northeast India" was held for the trainees of Dimoria Development Block of Kamrup district from February 2 to 6, 2013 at Capuchin House, Guwahati. There were 13 trainees in the programme.

LCHR ACTIVITIES IN THE NEWS:
